Trainers Schooling Horses Policy

If you are going to have your trainer, or anyone else, school your horse on show grounds, **HE/SHE MUST SIGN THE TRAINER RELEASE FORM BEFORE MOUNTING THE HORSE.**

A properly fitted and fastened ASTM/SEI-Approved helmet must be worn by all riders at all times while mounted.

NUMBERS ARE TO BE WORN BY ALL HORSES WHEN BEING RIDDEN.
